## AMENDMENT #3 TO COVENANTS AND RESTRICTIONS FOR HIGH RIDGE VILLAGE

Amendment to Article V. Lot Servitude Section 35. Signs, as follows:

Section 35. <u>SIGNS</u>. No signs of any kind including "for Sale", and other similar signs shall be displayed to the public view, erected or maintained on any Lot except for (i) one (1) professionally lettered sign not more than three feet square in size and no taller than three (3) feet in height from the ground, which shall only be allowed to be present on Lot for no more than 180 consecutive days, and then not for period of time of the following 120 days, advertising the property for sale; (ii) signs approved by Developer used by a Builder to advertise the Lot(s) during the construction and sales period, or (iii) as may be required by legal proceedings.

Amendment to Article V. <u>Lot Servitude</u>. Section 65. <u>CABLE TELEVISION</u>, shall be as follows:

Section 65. <u>CABLE TELEVISION/HI-SPEED INTERNET</u>. The Declarant shall have the exclusive right to furnish to all Homeowners within the Properties, cable television and hi-speed internet services as the Declarant deems appropriate, including without limitation of a broadband reception service, but said cable service is not required by the Homeowners.
